

## Section 17

### Motor Vehicle License Taxes, 2000

Section §46.2-752 of the *Code of Virginia* authorizes cities, counties, and towns to levy a license tax on motor vehicles, trailers, and semi-trailers. The amount of the tax may not be greater than the tax imposed by the state. Currently, the state license plate fees for non-commercial passenger vehicles are \$23.00 for those weighing under 4,000 pounds and \$28.00 for heavier vehicles (§46.2-694). The *Code* stipulates similar guidelines for commercial vehicles, buses and other motor vehicles. The *Code* also provides for a \$2.00 addition to the state license fee for emergency medical service programs (§46.2-694) and provides for a \$1.50 addition for the official motor vehicle safety inspection program to be paid at registration (§46.2-1168). Further, no locality may impose a license tax on any vehicle when the owner pays a similar tax to the locality in which the vehicle is normally stored, nor may it impose a local license tax on any vehicle that is owned by a nonresident of such locality and is used exclusively for pleasure or personal transportation. Vehicles used for state business by nonresident officials, dealer demonstration vehicles, and the vehicles of common carriers are also exempt from local license taxes.

If a town within a county levies a motor vehicle license tax, the county must credit the owner with the tax paid to the town. Also, if the town tax is equal to the maximum allowed by law,

then the county may not impose any further tax. Likewise, no county license tax may be imposed on vehicles that are subject to license taxes imposed by a town constituting a separate school district.

**Table 17.1** presents the local motor vehicle license taxes on automobiles, motorcycles, and trucks. All 40 cities report imposing the tax. Ninety three of the counties, all except Buchanan and Dickenson, impose the tax. Of the reporting towns, 140 say they will levy the tax during the 2000 tax year. Rates are indicated as either a flat rate, e.g., \$15, or by a range such as \$10-\$175, which represents the minimum and the maximum tax by weight. Column one indicates the date that the decal must be affixed to a motor vehicle to denote payment of license fees. Section §462-602 of the *Code of Virginia* requires the display of decals by the date dictated by the governing body. The second column gives the tax rate on private passenger vehicles. Most localities levy a flat rate between \$20 and \$30. The table also shows the exemption status for elderly or disabled persons. Four cities and counties offer a reprieve for the elderly, while twelve exempt the disabled from this tax. The final two columns give the tax rate on motorcycles and trucks. The tax ranges from \$5 to \$25 for the former and from \$5 up to \$250 (depending on weight) for the latter.
